Entries that are mechanically reproduced, copies, illegible, incomplete, or inaccurate and entries by any means which subvert the entry process are void. Each web entry will count as one (1) entry to the Sweepstakes and has an equal chance of winning. Limit one (1) entry per person throughout the Sweepstakes Period by drop box or on the web. Entries that are digitally reproduced, copies, illegible, incomplete, or inaccurate and entries by any means which subvert the entry process are void. Entries become property of Solvay Bank and will not be acknowledged or returned. An incomplete entry or an entry not complying with these Official Rules are subject to disqualification, at Solvay Bank's sole discretion. There will be a total one (1) random drawing conducted by the Solvay Bank Marketing Department on/about March 25, 2024 whose decisions are final and binding in all respects. Limit one (1) prize per person, per household and/or address.
